The Board of Directors of the Wyrope Williamsport FCU have voted to declare the dividend for the 2nd quarter of 2025. The declared dividend base share/savings rate is 0.20% APY*; all other share/savings accounts were declared at 0.15% APY*; and regular share draft/checking accounts will pay 0.13% APY*.
